NIH — Government Acquisition Management System (STARS Automation)

Scope IT Consulting assisted National Institute of Mental Health to design, build and support state of the art Acquisition Management system. As part of the contract, Scope IT Consulting built the Acquisition system to manage New Task Orders, Task Order Revision, Funding Request, Travel Request and Order Management process for all the 27 NIH Institutes and Centers. This new system streamlined the paper and email based process to online, mobile ready solution within 6 months. Scope IT was awarded 'NIH Directors Award 2021' for this solution.

NSF — Investigative Case Management

Scope IT is implementing yet another modern federal law enforcement investigative case management and administrative system for the Office of Inspector General (OCI) at the National Science Foundation (NSF). The system manages criminal investigative case information, provides a decision-making tool to conduct investigative analysis, generated investigative and administrative statistical and summary data, automated business processes and approval workflows, and enhanced system security to better protect sensitive law enforcement data.

State of Georgia — Government Grants Management

State of Georgia was looking for a vendor to modernize their NHTSA funded grants management solution for awarding grants to its citizens to address national traffic safety priority areas. We delivered a modern grants management solution that allows Grantees to respond to new opportunities, create progress reports, and submit claims. Grantors are able to manage multiple grants, view all grant applications, award grant proposals, allocate funds to appropriate funding accounting and participate in workflows for claims, progress reports, and grant closing, among several others. Scope IT Consulting delivered the project within 4 months of signing the contract.

CDC — Milestone Tracker App

Scope IT supported the "Learn the Signs. Act Early" (LTSAE) program in the Center for Disease Control and Prevention (CDC) by updating its "Milestone Tracker" mobile app to assist families in monitoring their child's, between ages of 2 months to 5 years, development over time. Scope IT supports more than 500,000 families through this app. Scope IT added in-app survey prompts, integrated AppStore reviews, connected users to local resources through geo-location services, and implemented a new child development tracker. The rating of the app improved from low 2s to 4.5+ within first 3 weeks of the release on both iOS and Android platforms.

Kansas School of Blind — Patient Management System

Scope IT was awarded the contract to build KSSB's Patient Management System. Scope IT hosted the system on Amazon's GovCloud. The solution allowed KSSB support staff and field specialists to keep track of all KanLovKids evaluation clinics across the State, patients enrolled in those clinics, and patient information. Doctors can access the system to evaluate patients attending the clinic, enter prescriptions, assess and provide final report. Scope IT also migrated existing patient data and reports to the new system.

State of Georgia — Mobile App

State of Georgia — Department of Driver Services (DDS) wanted to serve their 8 million+ drivers digitally to reduce the traffic in their Driver Services office. Scope IT was awarded the contract to build the mobile app to carter the need of the citizens with DDS 2 GO mobile app. With this app Georgia motorist have the ability to apply for license, renew their license, update address, pay fees and fines, update documents and much more for their driving needs.
